KEY POINTS	<ul style="list-style-type: none"> <li>• The UMC remains intact.</li> <li>• Creates a consistent, equitable regional conference structure worldwide.</li> <li>• Creates a new regional conference in the U.S. through a two-stage process: Stage I - Creates an interim U.S. regional committee of the General Conference to handle U.S. matters. Stage II - Creates a U.S. regional conference comprising the current jurisdictions, which continue with the same powers and geographic areas.</li> <li>• An Interim Committee on Organization plans the U.S. regional conference (effective at the close of GC 2020 with GC approval of the U.S. regional conference).</li> <li>• All regional conferences may create or abolish jurisdictions, upon majority consent of the annual conferences in the jurisdiction. Retains the current powers and duties of jurisdictions.</li> <li>• GC 2020 authorizes a study to perfect the new regional conference structure (effective at the close of 2020 GC with GC ratification of constitutional amendments to create global regional conferences).</li> <li>• No changes proposed regarding general church assets or agency structure.</li> </ul>	<ul style="list-style-type: none"> <li>• The UMC remains intact.</li> <li>• Does not call for a major restructure of the UMC.</li> <li>• Creates a new regional conference in the U.S. through a two-stage process: Stage I - Creates an interim U.S. regional committee of the General Conference to handle U.S. matters.
